HEALTH:

Your puppy is guaranteed to be in good health at the time of sale and to have all age-appropriate shots. The buyer agrees to take their new puppy to their own vet at their own expense within 28 days from the date of purchase.

The buyer agrees to provide regular socialization for the puppy after the pup is fully vaccinated and provide a clean safe environment for the puppy to grow.

The buyer agrees to keep the puppy healthy, maintain and stay current with all puppy vaccinations, provide periodic vet checkups and to keep the puppy at a healthy weight by feeding quality dog food.

A 30 day trial of Trupanion pet insurance is included in the purchase price of the puppy. You must activate your trial within 24 hours of receiving the email from Trupanion. We encourage you to enrol your puppy in a pet insurance plan as this is the best way to ensure your puppy gets proper medical care at affordable rates.

**NO BREEDING:**

As part of the purchase agreement the buyer agrees that they will get their puppy spayed or neutered at approximately six months of age but no later than one year of age depending on your veterinarian's advice and will not breed their puppy.

**I TAKE MY PUPPIES BACK**

If for some reason the Buyers find themselves unable to properly care for the puppy at any point throughout its life, the Buyer agrees that they will return the puppy/dog to the Seller. The seller will take the puppy back but no refunds are offered. The Buyer agrees that the puppy will NOT under any circumstances be placed in a dog pound or rescue center, or given or sold to another person without the written consent of the Breeder.

**PICTURES:** The buyer agrees to send the Breeder one picture a month of their puppy for six months suitable for Instagram. (More if the buyer wants) These pictures allow other prospective buyers to see what future puppies may look like.
